***Conditions Governing Reproduction of Works of Art in the Collection of the Missoula Art Museum
(hereafter referred to as MAM)***

1. Orders must be prepaid in US funds payable by cash, check, international money order or major credit card.
2. MAM does not give credit or refunds for any reproduction services.
3. Allow at least three (3) weeks for the delivery of reproductions of any format.
4. Permission is granted only for one usage in one publication, one edition, and in one language. Additional language editions and subsequent revised new editions will be considered upon application. Photographic material may not be reused without the written permission of MAM. Under no circumstances may transparencies be duplicated.
5. The complete credit line as specified must appear on the same page as the reproduction, or on the opposite page, or on the reverse. If MAM's reproduction(s) would be the only one(s) in this publication giving the full information in one of the above stated locations, then you may list only the artist's name, title of work, media, and date. However, the complete documentation must appear elsewhere in the book. In the case of filmstrips, visual credits must appear at the beginning or at the end.
6. The object(s) may not be cropped, bled, or overprinted and nothing may be superimposed on the reproduction(s). A specific detail must be approved in advance by MAM, and the word "detail" must appear in the caption. Reproduction(s) must be full-tone, black and white or full color, and must be printed on white stock.
7. In the case of works by living artists and/or subject to the 1978 Copyright Act, written permission must be secured by the applicant from the artist, their agent, or copyright owner.
8. MAM assumes no responsibility for royalties or fees claimed by the artist or other third parties.
9. MAM is to receive, gratis, one copy of the publication in which the reproduction appears. Printed material published in conjunction with filmstrips, video, or television presentations must also be sent, along with a copy of the film or tape. Send attention: Rights and Reproductions.
10. If so indicated below, MAM must approve in writing a proof of any reproduction in color before publication.
